# PERSONAL PENALTY - UNPAID PERSONAL TAX FEES & LATE FILING PENALTY

Signature

You will owe interest & penalties on any tax not paid by **APRIL 15th**, regardless of filing an extension. Extensions only extend the due date for the return, to avoid a late filing penalty. They **DO NOT** extend the due date of the payment. If you **DO NOT** file an extension and **DO NOT** file your return by **APRIL 15th**, the IRS will charge you a **failure to file** penalty - which is usually 5% of your unpaid tax per each additional month late.
